

# TERMS AND CONDITIONS

Standard Terms and Conditions for MAMA Network Members

## 1.) Scope

These Standard Terms and Conditions shall govern the contractual relationships between activated MAMA Network Members (hereinafter a Trial Member or Active Member) and Mama Corporation Ltd. These Standard Terms and Conditions shall apply in conjunction with the supplementary standards of conduct (Policies & Procedures), which are an integral part of the contract.

## 2.) Conclusion of the Contract

This Membership Contract shall enter into force upon acceptance of the online registration as a Trial Member.

## 3.) Material Contract Requirements

Non-Refundable handling-fee for Trial Membership on MAMA Network is us\$69 and or its equivalent in local currency of member and shall be paid upon the registration. Payment is valid for 12 months from the online registration and shall be automatically renewed if member's status is still Trial Member.

## 4.) Termination

The contractual relationship may be terminated by both parties by giving 14 days notice, unless otherwise provided for under Policies & Procedures.

## 5.) Remuneration

Remuneration shall be governed by the current remuneration scheme. Accordingly, 100% of the commissions and bonuses earned shall be paid into an online account. This account may also be used by the Members for transfers to other Member's accounts. Interest and fees shall not be payable for such accounts. The funds in these accounts may, among other things, also be used for the purchase of products pursuant to Point 6. And 7.

## 6.) Purchase of Products/Services

A selection of individual products/services, when available, can also be purchased in MAMA Network Shop.

6.1.) The ordered goods (where applicable) shall be supplied to the address stated in the order of the Members. The Members shall pay the shipping costs. The risk of loss or deterioration of the goods shall pass onto the Members from the moment they are handed over to the forwarding agent.

6.2.) The Members shall inspect the supplied goods immediately upon delivery. Reports concerning damage or loss received by MAMA Network later than one week after delivery shall not be taken into consideration, unless the damage could objectively not be detected at an earlier point in time.

6.3.) MAMA Network shall be entitled to replace ordered goods no longer deliverable by similar goods of equal quality. The Members may reject such delivery and demand reversal of the transaction. In such case, MAMA Network shall bear the costs for the return shipment.

6.4.) The delivered goods shall remain the property of MAMA Network until their complete payment.

6.5.) The Members warranty claims shall be limited to subsequent delivery of goods. Only if this is not possible or if it involves unreasonable expenditures for MAMA Network shall the Members be entitled to reduction of the purchase price or cancellation of the contract.

6.6.) Compensation for damages other than damages for harm to body, life or health shall be excluded, unless such damages are based on intent or gross negligence.

6.7.) Any return of goods by the Members or his/her Downline will raise an equivalent decrease of sales. The compensation will be recalculated based on the actual number of sales. This may lead to a debiting of Members commission account.

## 7.) Applicable Law

This Contract shall be governed by the laws of England and Wales with any consumer law requirement governed by the country where the Members has his place of residence.

## 8.) General Provisions

In the event that any provision under these Standard Terms and Conditions should be invalid, this shall not affect the validity of the remaining provisions.
